**Subject:** POP STAT PROGRAM – Monthly Report

The Monthly Activity Report for the park police that patrol District Parks during the month of November 2022 is attached. The District receives patrol services under contract with the Fulton El Camino Recreation and Park District, Police Department.

## Codes Referenced in the Report -

#### CA Vehicle Code referenced in the Reporting Period, follows:

**5200** (a) When two license plates are issued by the department for use upon a vehicle, they shall be attached to the vehicle for which they were issued, one in the front and the other in the rear.

**22500.1** In addition to Section 22500, no person shall stop, park, or leave standing any vehicle, whether attended or unattended, except when necessary to avoid conflict with other traffic or in compliance with the directions of a peace officer or official traffic control device along the edge of any highway, at any curb, or in any location in a publicly or privately owned or operated off-street parking facility, designated as a fire lane by the fire department or fire district with jurisdiction over the area in which the place is located.

The designation shall be indicated (1) by a sign posted immediately adjacent to, and visible from, the designated place clearly stating in letters not less than one inch in height that the place is a fire lane, (2) by outlining or painting the place in red and, in contrasting color, marking the place with the words "FIRE LANE", which are clearly visible from a vehicle, or (3) by a red curb or red paint on the edge of the roadway upon which is clearly marked the words "FIRE LANE".

### Sacramento County Ordinances in the Reporting Period, follows:

#### 9.36.050 Failure to Obtain Required Permit.

No person shall use, occupy, or otherwise remain in any park facility or portion thereof for which a permit is required without first having obtained such permit. (SCC 36 § 2, 1971.)

#### 9.36.061 Animals.

a. No person shall:

- 4. Bring into, maintain or allow in or upon any park facility any dog, cat, or other animal except a horse, unless such animal at all times is kept on a leash of sufficient strength and durability that it cannot be broken by the animal so leashed, and no longer than six feet in length, and be under the full and complete physical control of its owner or custodian at all times. Notwithstanding the provision of this subsection (a)(4), the Director may designate:
- i. Areas and times where such animals may be unleashed for purposes of show, demonstration, or training,
- ii. Areas and times where such animals are wholly restricted from entering designated parks or park areas;

#### 9.36.065 Motorized Vehicles.

- D. No person shall park any automobile, Class 3 electric bicycle as defined by California Vehicle Code section 312.5, motorized bicycle or moped as defined by California Vehicle Code section 406, or other motorized vehicle within any park facility except in areas specifically designated as parking areas. In no case shall any person park a motorized vehicle in a manner that presents a hazard to the public.
- E. No person shall park or otherwise allow automobiles and other conveyances to remain within the boundaries of any park facility during the hours the facility is closed without a permit from the Director.

### 10.16.050 Parking Space Markings.

b. When such parking space markings are placed in the highway, subject to other and more restrictive limitations, no vehicle shall be stopped or left standing other than within a single space unless the size or shape of such vehicle makes compliance impossible. (Ord. 703 § 40, 1960.)

#### 10.24.030 No parking zones.

b. When signs authorized by provisions of this section are in place, giving notice of the provisions thereof, no person shall stop, stand/or park any vehicle contrary to the directions and provisions of such signs. (Ord. 703 § 60, 1960.)
